Abortion is a Constitutional Right

(Response to Robin cont'd.)

Professor Micheline Matthews-Roth, Harvard University Medical School: "It is incorrect to say that biological data cannot be decisive.... It is scientifically correct to say that an individual human life begins at conception.... Our laws, one function of which is to help preserve the lives of our people, should be based on accurate scientific data."

Abortion takes the life of an innocent human being. We as a society do not allow the taking of innocent life in any other context. Human beings have an inalienable right to life. The Declaration of Independence asserts: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness." The 14th Amendment to the Constitution reaffirms the right to "life, liberty, or property".

We can argue over when a few divided cells become a human being and never settle it. The question on abortion is that of body autonomy which is a critical component to the right to privacy that is protected by the Constitution. See Griswold vs Connecticut (1965), McFall vs Shimp (1978) and Roe vs Wade (1973). The same way you cannot force someone to donate bone marrow or their organs after death to save a life, you cannot force the use of a woman's uterus to save a life. It must be voluntary. Whether or not you think it moral or immoral, the law is clear. A woman has the right to decide for herself.

Robin, please consider the body autonomy of the unborn child. The unborn baby is a separate body - a separate human. As a human being she has certain inalienable rights - the right to life being one of them. The woman's right to body autonomy is best exercised before she and her partner have created another living human being.

We should not punish women who find themselves in an unintended pregnancy. We should provide a full generous spectrum of resources. Neither should we punish the unborn human by ending its life. Respectfully, there are two bodies and two humans involved.
